Research Integrity Annual Statement 2018-19

Introduction

The University is committed to meeting the Commitments of the Universities UK *Concordat to support Research Integrity*. As part of that commitment the PVC Research, as the University's designated point of contact for research integrity matters, will provide an annual report on research integrity to the University Court which will:

- provide a summary of actions and activities that have been undertaken to support and strengthen understanding and application of research integrity issues
- provide assurances that the processes they have in place for dealing with allegations of misconduct are transparent, robust and fair, and that they continue to be appropriate to the needs of the organisation
- provide a high-level statement on any formal investigations of research misconduct that have been undertaken

Key Activities in 2018-19

The following summary outlines actions and activity undertaken to support research integrity during session 2018-19:

- 1. The updated Regulations for the Award of Master of Philosophy, Professional Masters, Doctor of Philosophy and Professional Doctorate were approved by Senate 1 June 2018 with minor additions required by Senate agreed on 12 October 2018.
 - A working group established by Research Degrees Committee is reviewing *the Regulations for the Award of PhD by Previous works* with a view to publishing a revised version for session 2019-20 following the relevant approval processes of Senate and its Standing Committees.
- 2. Data Protection guidance (incorporating GDPR guidance) has been published on the University intranet. The *Research Ethics Principles and Procedures Handbook* is being refreshed to update terms, links and references. A review of the University's and provision of information related to ethical procedures (at University and School level) on the website and intranet is being undertaken.
- Authorship guidelines have been adopted and linked to the GCU Research Integrity webpage (https://www.gcu.ac.uk/research/researchintegrity/).
 PGR Student specific guidance will be added to relevant webpages (Graduate School/Research Integrity).
- 4. A review of PGR Student guidance is ongoing and in the process of developing a robust guidance framework with appropriately up to date cross referencing to University Policy, Procedure and Support.
- 5. Via research networks, the Graduate School and Research Degrees Committee, work is ongoing to identify enhancements to PGR training provision in research integrity and key areas related to research integrity (research ethics, research data management, authorship). The relevant web pages are updated as content is refreshed and policy

- development is approved via Senate and the Standing Committees.
- 6. A Research Web Group has been established to review, update and maintain web content related to research, including areas relating to research integrity. The Group will seek to make relevant documentation more accessible to the public via more explicit placement on the University website and review published policy and procedure to ensure that they are consistent and web content is up to date.
 - Content refresh and creation (see 1-4 above) is continuing in a number of different areas and added to relevant webpages when approved.
- 7. Research specific data protection/GDPR information session was provided by Thornton's (University Solicitors). Dissemination has been largely via electronic means so far (web and intranet). Provision of research integrity related researcher development has been included in the DARE (Developing Academic Researcher Excellence) Steering Group remit with a view to identifying appropriate methods of disseminating policy, procedures and embedding research integrity principles in all GCU researcher development.
- 8. The extent to which all policies and procedures address the broad areas of the Concordat to support Research Integrity has been reviewed using the UKRIO Self Assessment Tool and taking note of the UUK consultation on a revised Concordat. With this in mind it is intended to establish a named senior member of staff as "first point of contact" for anyone wanting more information on matters of research integrity, in addition to the PVC Research who will be the named member of staff with the responsibility to oversee research integrity. It is intended that the Assistant Vice Principal Research will undertake the first point of contact role.
- 9. School Research Committees received the 2017-18 Research Integrity policy statement for consideration and raised no specific subject-area issues.
- 10. The Research Ethics Subcommittee has been renamed Research Ethics and Integrity Subcommittee.
- 11. Research Integrity is now embedded in PGR Student induction and researcher development.
- 12. Scoping of reporting mechanisms is ongoing (potentially integrating elements from REIS, RDC, DARE, People Services, Department of Governance).

Ongoing and Future Activity

- 1. To review policy and procedure to ensure compliance with the updated Concordat to support Research Integrity.
- 2. To investigate means by which matters of research integrity can be raised both formally and informally and ensure researchers can access appropriate advice.
- 3. Investigate how collaborative and shared approaches to ethical guidelines and codes of conduct can be implemented.
- 4. To explore, via the DARE Steering Group, how to embed research integrity in all

researcher development activity.

- 5. Development of guidance in relation to research data management.
- 6. To ensure that web content related to research integrity is updated as appropriate.
- 7. Consultation with the Associate Deans for Research to identify potential research integrity "champions" within the Schools.

Formal investigations of research misconduct

- No cases of research misconduct in 2018-19 (to date).
- No new cases of research misconduct by postgraduate research students in 2018-19;
 1 ongoing
